Results

Introduction

The parish Plan Update 2013 was initiated in order to find out if opinions had changed since the original Parish Plan which was published in 2010 and to inform the Parish Council and other organizations so that the views of Whitstone people can be represented

In order to be able to carry out a direct comparison the same questions were asked as before and several new questions were added relating to new subjects which have arisen since 2010.

Survey booklets were distributed along with delivery of 'The Whistler' and 37 were completed and returned, which represents responses from 75 individuals.

The raw results of the survey are presented here along with all the written comments that were made in response to the questions asked.

These raw results will be published on the village website. Later the results will be compared with the results of the 2010 survey and there will be a full version of the Parish Plan along with a summary from the Parish Council and an action plan.

The 2013 update to the Parish Plan has been produced with zero cost to the Parish and our thanks go to The Whistler Committee and delivery volunteers as well as Phil Tucker for printing, Irene Sutton for the website and Parish Councilors for supporting the production.

Balsdon Road Junction around shop - very dangerous.

B3254 from Whitstone village to Cherry Cross.

Balsdon Road junction with B3254 very dangerous.

Bennetts corner, Tankins corner, bends south of the Bridgerule turning.

B3254 anywhere and everywhere between Launceston and Red Post.

Meadowside/Balson Road junction when there are cars/lorries incorrectly parked by the shop, OK along main road, narrow section of road between Northmoor and Cherry Cross.Corner north of Tankins on B3254, Junction with lane to Froxton and others, signage could be much improved using flashing illuminated automatic signs activated by cars.Green Lane junction, junction to Whitstone Head School entrance.

No. Vehicles heading south along B3254 invariably exceed the 40mph limit, ditto Northbound.

40mph lengths should become 30mph and other measures to encourage speed reduction.

500+ drivers still speed through village, we need speed cameras that work and fine the drivers at fault.

If a pavement is not possible (Q4) then maybe traffic calming might make it safer: Humps at the 30mph sign just south of the shop crossroads.

Main road through Whitstone.

More police control or speed cameras.

Psychological measures would be a cost effective solution, perhaps a crossing point near Paradise Park would slow traffic somewhat.

Humps through the village on the main road.

At least one, if not two pedestrian crossings (villages in France use traffic lights to stop traffic if speed limit exceeded even if no pedestrians crossing, restrict road width to allow one vehicle at a time to proceed, see main A road (Bath to Shepton Mallet) in Stratton-on-the-Fosse, Somerset.

Outside Paradise as this is where most children cross to school.

(These turbines are generally considered to be for self-sufficiency purposes to support a property or micro business with their energy needs.)

Turbines with a tip height of greater than 60m or installed wind power of greater than 100KW WPC will consider these as large scale turbines being installed for exporting power and as such will seek a community benefit from the owner based on a minimum of £8000 per Megawatt of installed power
